NHS Test and Trace: COVID-19 testing for staff and pupils

Dear Parent or Carer,

I hope that you and your family had an enjoyable festive break, notwithstanding the COVID-19 restrictions that we are all living with.

My letter today includes important information relating to the COVID-19 testing process for staff and pupils.

Information relating to NHS Test and Trace: COVID-19 testing for staff and pupils

You may have heard that testing for those without coronavirus symptoms is beginning across the country using COVID-19 tests known as 'lateral flow tests'.

Along with the other protective measures we are taking, these tests can help staff and pupils remain in school safely. Up to one third of people who have coronavirus experience no symptoms. By testing we will help to stop the virus spread and help to keep our school open as safely as possible. The test is voluntary.


We will soon be testing all staff and pupils who want to participate and will contact you shortly with more details about when this is due to start.

I enclose an instructional leaflet with some more information (below) as well as a consent form (attached).

If you are happy for your child to be tested, please complete the online consent form for COVID-19 testing in secondary schools and colleges (one per pupil), which will enable us to register and complete the test(s) for your child, by Friday 8th January at midday.

If your child is over 16 years of age and is happy to be tested, please ask them to complete and return the consent form, having discussed participation with yourselves if they are under 18.

Those taking the test will be supervised by trained staff. The lateral flow tests are quick and easy using a swab of your nose and throat. Results take around half an hour from testing and will be shared directly with staff and pupils participating. Where participants are under-16, parents or legal guardians will also be informed if they need to take a further PCR test.

What if a pupil tests positive?

Participating staff and pupils who test positive will be informed about their results individually. Where participants are under 16, parents or legal guardians will also be notified. Guidance on safe travel and additional precautions will be provided along with test results.

Pupils will need to take a further 'PCR test' (similar to those done in local and regional testing sites) on the same day (or as soon as possible). You can go to www.gov.uk/get-coronavirus-test or can call 119 to book a follow-up test. If ordering a PCR test yourselves, they should choose to visit a drive-through test site if possible, as it is faster than requesting a home test.

During the time while they wait for the PCR result (via text/email), the students will need to self-isolate.

If the PCR test confirms a positive result you will have to self-isolate and follow the guidance from NHS Test and Trace.













What happens if the test is negative?

They will be able to stay in school and resume their activities as normal. A pupil will only be told if they test positive on a lateral flow test, so if you do not hear you can assume it was negative. A small number of pupils may need to repeat the test if the first test was invalid or void for some reason.

What if a close contact at school tests positive?

A close contact of someone in school/college who has tested positive for COVID-19 will be able to return to school if they agree to be tested once a day for seven days and the test is negative. If they do not want to take the test, they will need to self-isolate as per the national guidelines. This does not apply to household members or close contacts outside school who will still need to self-isolate. Further details will be provided at the time, but if you would prefer to self-isolate instead of doing daily testing, you can.

What if my child develops symptoms?

This testing programme at school is for people with no symptoms. If your child develops symptoms at any time (such as a high temperature; a new, continuous cough; or a loss or change to their sense of smell or taste) they must immediately self-isolate, and book a test by calling 119 (England, Wales and Northern Ireland) or 0300 303 2713 (Scotland) or visiting https://www.gov.uk/get-coronavirus-test.
